#### **Article 1 – Purpose**

The Client hereby appoints **Marriotts Legal Services Ltd (“MLS”)** to represent them in connection with the ongoing **Class Action Campaign, organized and sponsored by Connex Corporate Ltd**, concerning fraudulent transactions and violations of civil and contractual rights.

#### **Article 2 – Legal Status of MLS**

**2.1** MLS is a para-legal firm.

**2.2** All legal actions, filings, and proceedings are carried out in association with accredited local and international law firms, competent authorities, and recognized organizations.

**2.3** This structure ensures full enforceability of claims, proper representation before judicial and administrative bodies, and compliance with all applicable laws.

### **Article 3 – Scope of Representation**

MLS, together with its associated law firms, is authorized to:

- a) Collect, examine, and submit the Client's evidence.
- b) Draft and file legal documents required for inclusion in the Class Action.
- c) Act jointly with appointed attorneys to represent the Client before courts, authorities, and enforcement agencies.
- d) Take any preparatory, administrative, and procedural steps required for the effective prosecution of the claim.

### **Article 4 – Client Obligations**

**4.1** The Client undertakes to provide **complete and truthful documentation**, including but not limited to:

- Original or certified contracts and agreements
- Correspondence and letters
- Payment receipts and bank records
- Any other material evidence of relevance

**4.2** The Client agrees to cooperate fully with MLS and its legal partners, responding to reasonable requests for information in a timely manner.

### **Article 5 – Fees and Administrative Costs**

**5.1** The Class Action shall be handled strictly on a pro bono basis.

**5.2** The Client is required to pay a **one-time administrative fee of GBP 250** to cover costs of processing, file administration, and evidence management.

## **Article 6 – Priority of Class Action**

The Client acknowledges that the Class Action is afforded the **highest priority and consideration by competent criminal courts and enforcement authorities**, ensuring a strong and coordinated approach to blocking, freezing, and recovering assets.

## **Article 7 – Confidentiality**

All documents, information, and evidence submitted by the Client shall be treated as strictly confidential and used exclusively for the purposes of the Class Action. MLS and its partner firms are bound by professional confidentiality obligations.

## **Article 8 – Duration and Termination**

**8.1** This Agreement shall remain in force until the conclusion of the Class Action, unless terminated earlier.

**8.2** The Client may withdraw from this mandate by providing written notice to MLS. However, any administrative fee paid is non-refundable.

**8.3** MLS may terminate this Agreement only for just cause, including but not limited to:

- Non-cooperation by the Client
- Submission of fraudulent or false documentation

## **Article 9 – Governing Law and Jurisdiction**

This Agreement shall be governed by and construed in accordance with the laws of **England and Wales**. Any dispute arising from or in connection with this Agreement shall be submitted to the exclusive jurisdiction of the courts of London, United Kingdom.

## **Article 10 – Acceptance**

By signing below, the Client confirms their full understanding, acceptance, and agreement to the terms set forth in this Mandate Agreement.

## **Article 11 – Assignment of Rights**

**11.1** The Client expressly authorizes MLS to delegate, assign, or transfer this mandate, in whole or in part, to accredited partner law firms and attorneys, whether in the United Kingdom or internationally, where necessary to ensure effective representation.

**11.2** Such assignment shall not diminish or limit the Client's rights under this Agreement.

**12.2** This mandate confirms that all legal services provided in relation to the Class Action are strictly pro bono, ensuring equal access to justice for all victims.
